NUJ President Norila Mohd Daud (Utusan Malaysia), General Treasurer Tauhid @ Hayat Sueet (Utusan Malaysia) and Deputy General Treasurer Chin Sung Chew (Sin Chew Jit Poh) retained their posts unopposed at the close of nominations on Sept. 12, 2000.

The six (6) Resolutions which was passed at the 12th Biennial Delegates Conference are:-

- 1. THAT the National Union of Journalists explores the possibility of setting up a National Press Council.
- 2. THAT the National Union of Journalists ensures that its members' individual rights to freedom of expression and communication are upheld and continuously demand for the repeal of Official Secrets Act 1972 and the Printing Presses and Publications Act 1984.
- 3. THAT the National Union of Journalists resolves that the 12th Biennial Delegates Conference gives mandate to the Executive Council to fix allowances, wages and working benefits for the staff of the NUJ headquarters.
- 4. THAT the National Union of Journalists resolves that the 12th Biennial Delegates Conference gives mandate to the Executive Council to engage more staff to serve the Union and to revise the budget estimates accordingly.
- 5. That the NUJ Executive Council must address within two weeks, all issues, especially those involving discipline, forwarded to it by branch committees and/or members. All matters relating to these issues must be submitted in writing.
- 6. That the NUJ Executive Council take an active role in the campaign by journalists to abolish the Printing Presses and Publications Act in the interest of greater press freedom.
